**Explanation of Responses:**

- Original performance-based restricted stock unit awards totaling 55,188 were adjusted by a ratio of 1.1070 on September 6, 2013 as a result of the spin-off of Murphy USA Inc.
- Represents performance-based Restricted Stock Units (RSUs) that have vested and settled in shares of the Company's stock on a one-for-one basis. Pursuant to the terms of the performance-based grant awarded under the 2012 Long-Term Incentive Plan, the total includes 45.775% of the original award, plus shares equivalent in value to accumulated dividends.
- Shares withheld for taxes on RSU vesting.
- Includes 81 shares obtained through the Company Thrift Plan. The information in this report is based on a plan statement dated December 31, 2015.
- Award granted under the 2012 Long-Term Incentive Plan.
- The option vests in two equal installments, the first half two years after the original grant date and the final half three years after the original grant date.
- These Securities generally do not carry a Conversion Price, Exercisable Date, or Expiration Date
- Vest date is February 2, 2019.
- Performance-based restricted stock unit award granted under the 2012 Long-Term Incentive Plan.
- Each phantom stock unit is the economic equivalent of one (1) share of Murphy Oil Corporation common stock.
- The reported phantom stock units were acquired under Murphy Oil Corporation's excess benefit plan and are to be settled upon the reporting person's retirement or other termination of service. The reporting person may transfer the value of his phantom stock units into an alternative investment account at any time prior to settlement.
- Includes 682 shares obtained under the Murphy Oil Corporation's excess benefit plan. The information in this report is based on a plan statement dated December 31, 2015.
